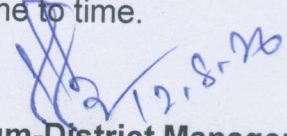

6. An undertaking from the advocate to the effect that all information furnished by him is correct and he is willing to abide by the terms and condition as to empanelment and fees.

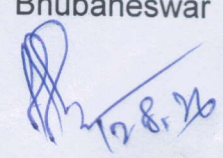
